The College of Education requests that the Vice Chancellor for Academic Affairs approve the addition of an elementary track to the existing Post-Baccalaureate Certificate in Teacher Education (PBCTE). The proposal is supported by the College of Education Faculty Senate and Dean's Office.

Fall 2020.

PURPOSE:

The purpose to add an elementary track to the existing Post-Baccalaureate Certificate in Teacher Education (PBCTE) is to provide a teacher preparation program that leads to licensure in Elementary Education for those who hold a bachelor's degree in another field.

BACKGROUND:

The Institute for Teacher Education (ITE) offers programs in secondary education (grades 6-12) at the Bachelor of Education, Post-Baccalaureate Certificate, and Master of Education in Teaching levels. However, ITE offers programs in elementary education (grades K-6) only at

the Bachelor of Education and Master of Education in Teaching levels. A track of elementary education at the post-baccalaureate level will fill this gap in COE teacher preparation offerings.

The elementary post-baccalaureate track will use the same course numbers as the secondary track. Course modifications have been be submitted to add the track for elementary teaching in grades K-6. Like all COE teacher preparation programs, the elementary track will be field-based, with candidates taking part in classroom observation and participation experiences in each semester prior to full-time clinical experience/student teaching in the final semester.

The need for the elementary post-baccalaureate track became more evident this year as we worked with Senator Michelle Kidani to create a new Grow Our Own Scholarship fund for Hawai'i Department of Education employees, (i.e., educational assistants, substitute teachers, emergency hires). Hawai'i Department of Education funded the post-baccalaureate secondary program as the quickest route to licensure for employees holding a bachelor's degree and provided \$600,000 in tuition funds to prepare 6-12 teachers beginning in January 2018. We anticipate additional rounds of funding that could include elementary teacher preparation and want to ensure we have all possible pathways in place.

ACTION RECOMMENDED:

The College of Education recommends that the Vice Chancellor for Academic Affairs approve the addition of an elementary track to the existing Post-Baccalaureate Certificate in Teacher Education (PBCTE).

Post-Baccalaureate Certificate in Teacher Education - Elementary Track January 2019

Introduction

The College of Education offers a Post-Baccalaureate Certificate in Teacher Education, recently approved on February 12, 2019. The Post-Baccalaureate Certificate in Teacher Education (PBCTE) currently includes one track in Secondary Education. This proposal presents the addition of a second track to the PBCTE – a track in Elementary Education. This field-based program is designed for those who have earned a baccalaureate in a field other than education and are interested in pursuing a career in teaching. Upon completion, graduates will be recommended for licensure in grades K-6. The courses for the Elementary track of the PBCTE are from established courses in the Institute for Teacher Education and similar to the courses in the Secondary track (see attached curricula comparison).

Need for the Program

The PBCTE – Elementary track would provide additional pathways to teacher licensure in grades K-6 for individuals who hold an undergraduate degree in a field other than education. It also will provide a pathway to teacher licensure for emergency hires, paraprofessionals and long-term substitutes currently working in Hawaii public schools. Providing multiple pathways to teacher licensure would address the growing need for qualified, licensed teachers in grades K-6 particulary in geographic areas that have historically experienced difficulty recruiting and retaining classroom teachers. The PBCTE- Elementary track will be offered in an online/hybrid format making it accessible to candidates on all islands.

Program Model and Courses

Pre-requisites. The pre-requisites for a PBCTE – Elementary track include:

- 1) An undergraduate degree from an accredited college or university
- 2) A cummulative GPA of 2.75
- 3) Completion of SPED 304: Foundations of Inclusive Schooling with a grade of C or better.

Courses for the Post-Baccalaureate Certificate in Teacher Education - Elementary. The

PBCTE - Elementary is a 33-credit program. Upon completion, graduates will be recommended for

licensure in Elementary Education, grades K - 6. The program includes:

- 15 credit hours of teaching in the content areas
- 3 credit hours of educational inquiry
- 6 credit hours of field experience/teaching practicum
- 3 credit hours of educating students with exceptional learning needs
- 6 credit hours of teaching residency (student teaching)

Policies. A grade of a C or above will be considered a passing grade for all students enrolled in the PBCTE – Elementary program. Students earning a C- or below, will need to retake the course. In addition, field courses may be repeated only once; failure to meet requirements on the second attempt will result in dismissal from the program.

Program Objectives and Outcomes. Teacher candidate's progress through the program (GPAs, completion rate, and time-to-completion) and competency attainment data will be used in constructing accreditation reports for internal program evaluation and improvement. Upon completion of the PBCTE – Elementary program, teacher candidates will be prepared to teach students in general education, grades K-6.

Program effectiveness will be addressed in multiple ways. Program graduates will be asked to complete program satisfaction surveys that collect data on their perceptions of how prepared they are to teach students in their licensure area. Surveys will also be sent to:

a) mentor teachers to assess their perception of program effectiveness

b) employers of graduates to assess their perception of the preparedness of our graduates

c) graduates to assess their perceptions of their readiness to teach in their area of licensure

Scheduling

Candidates will be admitted to the PBCTE – Elementary program once every year (fall) with a minimum of 15 students per cohort. Courses will be offered in an established sequence as described above (Program Model and Courses) and will be block scheduled by the program director, Dr. Kuulei Serna. Instruction will be delivered in an online hybrid format including asynchonous and synchronous and/or limited face-to-face sessions.

Recruitment and Tuition Support

Advertising for the PBCTE – Elementary program will begin in late fall, 2019 (pending approval). The first cohort will be admitted to begin in Fall, 2020. Recruitment meetings will be conducted by the Office of Student Academic Services (OSA). March 1, 2020 will be the application deadline for fall 2020 semester; potential candidates will be interviewed in Spring, 2020.

Recruitment activities will include substantial information on scholarships and financial aid. The Hawaii Department of Education (HIDOE) and the University of Hawai'i at Mānoa College of Education, with significant support of the Hawaii State Legislature, are partnering to offer a stipend-supported pathway to licensure for certain groups of the HIDOE employees starting in January. The current targets are secondary education and shortage areas. A long-term goal is to extend program planning to include elementary education, particularly in geographic areas that have historically experienced teacher shortages.

Personnel Resources

The PBCTE – Elementary program will be offered as part of the Institute for Teacher Education (ITE). Dr. Kuulei Serna, Department Chair for Elementary Education will provide program oversight and will assign faculty resources to the new program. Additional faculty will assist in program development and coordination. The Elementary track courses will be administered through Outreach College. Course instruction will be provided by existing ITE faculty who currently teach in the BEd in Elementary Education program or in the MEdT in Elementary program.

Relationship to College and Departmental Goals

The College of Education is committed to preparing teachers who are knowledgeable, effective, and caring educators to contribute to a just, diverse, and democratic society. The Post-Baccalaureate Certificate in Teacher Education (PBCTE) – Elementary track will provide alternative pathways to teacher licensure for individuals who hold a 4-year degree in a field other than education. The PBCTE – Elementary program is designed to meet the needs of professionals interested in careers in education, particularly emergency hires, para-professionals and long-term substitutes who are currently working in Hawaii public schools. The College of Education at the University of Hawai'i at Mānoa graduates account for 15.2% of new hires for Hawai'i public schools, a significantly higher number than graduates from other state-approved teacher education programs. This PBCTE – Elementary program is needed to contribute to the College of Education's principle goal of preparing knowledgable, caring and effective educators and to address the growing need for qualified elementary teachers in Hawai'i public schools.

BACKGROUND:

The Institute for Teacher Education (ITE) currently offers a post-baccalaureate certificate program only in secondary education (grades 6-12). However, ITE is developing a track in elementary education (k-6); the establishment of the Post-Baccalaureate Certificate in Teacher Education will provide a program under which to house the elementary track. Additional tracks may be added in the future to address the workforce needs of the Hawaii Department of Education (such as an Early Childhood track -PK-3). This program structure already exists in the Department of Special Education, COE. The Post-Baccalaureate Certificate in Special Education (PB SPED) houses a track in mild/moderate disabilities (MM) and a track in severe disabilities/autism (S/A).

Sorry, there was some confusion about this request. Part of the problem is the larger issue of the current structure of program codes for your college. We have talked in the past about changing your individual majors to concentrations, eg., Secondary education American Studies, to seondary education with a concentration in American Studies. This is why we thought it made sense to have a major with several concentrations. But after looking more closely, it doesn't make sense to use concentrations in this case. We recommend solution 2. But we are willing to go with solution 1 if that is your preference. We have enclosed the paperwork you can sign and submit for either option.

Summary:

- 1/31/2019 Memo request to change the existing Secondary Education-PCERT (EDSE-PCERT) program to a Teacher Education-PCERT program with a track in Secondary Education.

There are 2 possible ways to do this:

Solution #1 - Use existing major Teaching and create 2 program concentrations:

A program consists of a degree, major, and optionally a concentration.


- Degree: The degree is PCERT.
- Major: The proposed name of the major is Teacher Education. There
 is no existing major named Teacher Education, but there is a major
 Teaching (TCH) with the CIP 13.1299 Teacher Education and
 Professional Development, Specific Levels and Methods. It is used
 at Manoa, HIIo, and Leeward. We do not see a need for a new major
 code, but is there a reason for not using this existing code?
- Concentration: The concentration codes you requested currently exist.
 - Secondary Education (EDSE)
 - Elementary Education (EDEL)

Solution #2 - Keep existing Secondary Education-PCERT (EDSE-PCERT) program and add a new Elementary Education-PCERT (EDEL-PCERT).

Attached are the original memo requests and pre-filled Program Code Request forms.

Things to consider:

- Changing the major from Secondary Education (EDSE), which has a CIP 13.1205 Secondary Education, to the more general education major will require a change in the CIP code of the existing program. This will change how the program is reported internally and to IPEDS. We do not report concentrations to IPEDS.
- Normally when campuses set up concentrations, there is usually a core of similar classes, with a few classes different that makes it a concentration. But in your cases there are few similar classes. Thus it may make more sense to have the separate programs (Solution 2) rather than concentrations under a general education program (Solut
