Hi Stuart. So, the form is attached here, but they had a number of questions before it can be signed. Thank you!

Regarding the program code request:

I've attached the Program Code Request form to this email. We actually reached out to Stuart via email because we were unsure about how to answer some of the questions at the bottom of the first page, but we haven't heard back. So I've left them unanswered and if you are working with Stuart on the request then hopefully you can fill in the blanks. Here are our questions/concerns:

Is 50% or greater of the classes in this program offered at a location other than the Home Campus?

All social work courses are offered through UH Mānoa (home campus), but students are not all on O'ahu and may take some general education requirements (like language) at/through other campuses. So we're not sure how to answer this question, especially as it relates to financial aid eligibility.

Program Length (In academic years; decimals are acceptable. The length of the program should match what is published by the campus in any online and/or written publication.)

The length of the program is the same as the campus-based BSW Program (minimum of 2 years starting from the time of admission after completing GenEd core, possibly longer if admitted early). We do not know what is currently in the system for the original BSW Program code but it should match that one.

Required Terms of Enrollment

Is this question for financial aid eligibility or continued enrollment? Students are not required to enroll in summer in order to maintain enrollment, but we want to be sure all students are eligible to apply for financial aid for the summer. (We think the answer to this should also be the same as whatever is associated with the current BSW Program code.)
