It is requested that the President approve Leeward Community College's request for a program name change from Plant Biology and Tropical Agriculture (PBS) to Sustainable Agriculture (AGSU), which is a provisional program and received an extension until June 30, 2023.

PURPOSE:

The name change reflects the focus of the program. As a whole, the classes we offer (e.g. soil science, organic agriculture, plant propagation and nutrition) are based on sustainable agriculture practices that are science based, environmentally sound and benefits our island community. The name change will make it easier for students to understand what the program is offering.

BACKGROUND:

Board of Regents Policy RP 5.201, Section IIIG1, Naming of Programs states "Program are given a name at the time they are approved by the board. Thereafter, the president may approve changes in the functional names of academic program and credentials as may become necessary to remain current with the terminology and focus of their fields and which involve no significant change in the program requirements."

The Associate in Science (AS) in Sustainable Agriculture will prepare students for various careers in agriculture through hands-on practice and classroom instruction. Students will gain fundamental skills, knowledge and experiences in sustainable crop production, pest management, business principles, food, agriculture and the environment. The program objectives are in line with the objectives and initiatives as stated in The University Hawai'i's of Community Colleges Strategic Directions 2015–2021: "UH Community Colleges are an integral component of the workforce development in the State of Hawai'i and a leader in identifying workforce needs and developing and delivering training programs to enable students to gain employment;" (pg. 2) "Hawai'i Innovation Initiative - workforce development linked to developing emerging sectors in Hawai'i's economy while simultaneously providing a stable workforce for the traditional employment sectors. " (pg. 3)

The program helps to provide the trained workforce needed in the state, the Asia-Pacific region, and internationally by offering occupational, technical, and professional courses, which prepare students for immediate and future employment and career advancement. According to the Bureau of Labor Statistics, U.S. Department of Labor Occupational Outlook Handbook, there is a projected growth rate of 5% in for Hawai'i Agriculture and Food Science Technicians

(https://www.onetonline.org/link/summary/45-1011.07). The 2010-2020 Employment Outlook for Industries and Occupations predicts 6,410 jobs in Agriculture, Forestry, Fishing and Hunting, which is a slight contraction from 6,470 jobs in 2010. Approximately 82% of the jobs in this sector are forecast to be in the area of crop production and support activities for agriculture and forestry sub-sectors (Hawai'i Department of Labor and Industrial Relations, 2012). Twenty-nine broad occupations in Hawai'i fall under the O*NET's list of Agriculture, Food and Natural Resource Occupations. David Lassner March 8, 2021 Page 3 of 3

Of these occupations, at least nine occupations require 1 to 12 months on-the-job training, another eight require longer than 12 months of on-the-job training (OJT) or some postsecondary vocational training or associate degree (Sustainable Agriculture Skill Panel Forum 2011, DLNR, State of Hawai'i).

Both government and non-government sections have established various strategies in order to improve agriculture, increase food security and food self-sufficiency, which will also keep money circulating in Hawai'i and greatly help Hawai'i's economy.

The AS in Sustainable Agriculture will provide postsecondary level education, which not only prepare farmers, returning non-traditional students and youth to start various occupations in agriculture successfully, but also lead to more employment opportunities and better pay in the workforce. It will utilize the existing classes offered in the AS in Plant Biology and Tropical Agriculture. It will also provide students with an opportunity to transfer to four-year programs at UH Mānoa, UH Hilo, UH West O'ahu.

The CIP code 01.1101 – Plant Sciences, General has been approved and aligns with the AS in Plant Biology and Tropical Agriculture and is relevant and aligned to the proposed name change to Sustainable Agriculture.

ACTION RECOMMENDED:

It is recommended that the program name be changed from Plant Biology and Tropical Agriculture (PBS) to Sustainable Agriculture (AGSU), effective Fall 2020.
