





PROPOSAL SUMMARY (Include reasons for modifying program.):

MERGE AEC AND CMGT:

The plan is to absorb the Construction Management (CMGT) program into the AEC program. Although the CMGT program did not survive its introductory trial period, CMGT classes were full in the last year, and its health calls were "cautionary" in respect to industry demand, "healthy" in efficiency, and "healthy" in effectiveness. It also placed the vast majority of its employment-seeking graduates (many were already employed in the industry) in construction management-related employment. It will, therefore, be a valuable asset to the AEC program. The plan has the full support of both the AEC and CMGT advisory committees, all instructors involved, the HCC administration, and our sister Hawaii Community College AEC faculty in Hilo. The two full-time CMGT instructors, one of whom is an AEC graduate, are also capable of teaching the full range of AEC courses, and both have construction and design backgrounds that fit the AEC program.

Many of the CMGT courses somewhat replicated AEC courses, so it's necessary to absorb only seven specialized construction management courses. The addition of these courses is being made possible by creating two focuses -- a construction management focus and an architectural technology focus involving the same amount of specialized coursework. Both focuses will also include common AEC courses and four general education courses (two different and two the same). Both of the focuses will be comprised of 65 credits, both will lead to the Associate in Science degree, and the degrees will be worded differently to distinguish their emphases to employers.

The program mission, description, SLOs, and course requirements are proposed to be changed accordingly. At the same time, two other proposed changes are as follows.

COURSE RENUMBERING:

With the addition of seven courses (one is an elective), with HawCC using some of the same and differently numbered AEC courses, and due to the fact that the numbers of previously deleted courses cannot be reused, it's necessary to expand the range of course numbers. Where courses in the four semesters are currently numbered in the series 110 to 119, 120 to 129, 130 to 139, and 140 to 149, it's proposed to number them in the series 110 to 149, 150 to 189, 200 to 249, and 250 to 289. HawCC has already done this.

DEACTIVATE THE AEC 81 PRE-PROGRAM COURSE:

The pre-program course AEC 81, Basic CAD Drafting, is being deactivated in part due to the system emphasis on "on time" graduation, the success that the HawCC AEC program has achieved without the course (an 87% graduation rate), the belief that students will do better when committing to a block of four AEC courses in the first semester, and the fact that the AEC 81 course material can be incorporated into regular-program courses.

SCIENCE (AS) DEGREE AND CERTIFICATE OF ACHIEVEMENT IN
CONSTRUCTION MANAGEMENT

SPECIFIC ACTION REQUESTED:

Approval to terminate the provisional Associate in Science (AS) degree and Certificate of Achievement (CA) in Construction Management (CMGT) at Honolulu Community College.

RECOMMENDED EFFECTIVE DATE:

Admissions stop-out in effect for Fall 2015. Degree termination to take place Spring 2017, with last graduating class in Spring 2017.

ADDITIONAL COST:

There are no additional costs to this request.

PURPOSE:

The purpose of this request is to terminate the provisional Associate of Science degree in Construction Management. This will include the removal of the Academic Program Code in Banner.

BACKGROUND INFORMATION:

In accordance with BOR Policy E5.202 Review of Established Programs, Honolulu Community College is requesting approval from the UH President to terminate the provisional Associate in Science (AS) degree in Construction Management.

This degree was originally created and provisionally approved in 2012 to provide a coordinated undergraduate program of preparation for middle level management needs of the construction industry. Recruitment strategies to identify early program participants targeted students from the Honolulu Community College's Construction Academy as well as individuals from the current construction industry workforce. Plans also included the development of a partnership with the UHM College of Engineering.

Projected student enrollment and completion goals placed approximately 40 students entering per year, totaling enrollment over the next three years at 80 majors. Actual student enrollment and student completions have been significantly lower with an average of 20 students entering each year with the first graduating class of three students. Further program and curricular modifications will not prepare students to transition to UH Mānoa because the lack of appropriate science and math requirements.


The College has determined the provisional program does not appropriately meet and address current and projected workforce demands. During the 2015-2016 academic year, the College has identified other opportunities to continue offering construction management related courses in other established construction related degrees and continuing education programs.

Honolulu Community College will continue to work directly with all CMGT program majors who have signed and returned a statement of intention declaring their future academic goals. Coordinated efforts throughout the College have been implemented to maintain consistent communication with students regarding changes to the program, and information to access various academic support services. The Spring 2017 semester will serve as the terminal semester for final degree confirmation.

Approval to terminate the provisional Associate in Science (AS) degree and Certificate of Achievement in Construction Management (CMGT) at Honolulu Community College.
