Students will develop their academic English vocabulary and writing by answering the question: *What do I need to know about college in the U.S. to be a successful student?* Learning activities will focus on vocabulary and communication needed to talk about and navigate college in the U.S.

This is excellent, Grant, thank you.

In terms of workflow, once completed would I return to you to route for signatures, or route via my chancellor?

Also, in terms of verifying your bulleted points:

- Assuming this is not financial aid eligible.
 - Correct.
- Program will be listed as a selectable program in the online application (Yes), or an advisor will manually input the students into the program (No).
 - We will plan on manually registering students.
- Program Duration: 9 weeks matching the credit hours, or 15 weeks for one semester?
 - We run a 16-week semester and a 10 week summer session. I updated the form.
- Special Program: Is this a Preparatory Coursework Undergraduate Program (U) - Coursework that prepares them for enrollment in an undergraduate degree or certificate program?
 - I am not sure about the implications of my response here, but completion of the IEP qualifies students for access to Ka[̄]iolani CC's placement tests and registration for credit courses. This is how the students would normally qualify for access to an otherwise open-door college.
- Terms of Enrollment: What are the semesters of enrollment? Typically this is Fall and Spring, but sometimes Summer and Extended Terms.
 - We run the program in the Fall, Spring and Summer. The summer term starts with the first UH 6-week summer session, but run for 10 weeks. I updated the form.

I've been asked to help answer some questions about Kapi'olani Community College's Intensive ESOL Program (IEP), a three-course, one-semester program for international students who study only English for Speakers of Other Languages due to their limited English proficiency, based on an admissions test (such as TOEFL).

Our goal is to be able to offer our three courses online in the Fall. In the email exchange below, Director Iboshi asked some questions. I'll respond in-line:

Are these students exchange students, so they have a home campus in another country?
Or are they just students taking this program, and with the possibility of maybe eventually becoming a regular student. **Both. Some students are here as part of an exchange, and their intention is to return to a**

home campus. Others come to us with the intention of completing the IEP and being able to register for credit classes. All the students have a managed registration process -- our office registers them into the three courses that comprise the IEP: ESOL 50, ESOL 52, and IS 54. At the end of the program, successful students may wish to continue. At that point the office issues them a new I-20, we remove the ESOL hold in banner, and we begin to integrate the students to campus via our New Student Orientation program (NSO2).

We can definitely do this. just trying to figure out an appropriate name.

Will other campuses also want to do this? We can create the code with a D and without a D so if things go back to normal they can use the same code for on campus.

It is not clear to me right now if other campuses will be doing this. I know that UH's HELP program's courses are not in Banner, so they are not having this challenge, and they are planning to offer their courses online as well.


Have the person at Kapiolani contact Grant to create a new program/major code.

I am here to help! We really hope to make this happen. Our goal is to be able to offer the IEP online for students living in other countries. Please let me know what I can do to help.
