



Approval of the termination of the Certificate of Competence in Agricultural Technology, Certificate of Competence in Plant Landscaping, and Certificate of Competence in Subtropical Urban Tree Care.

PURPOSE:

The purpose of this request is to permanently terminate the Certificate of Competence in Agricultural Technology, Certificate of Competence in Plant Landscaping, and Certificate of Competence in Subtropical Urban Tree Care.

BACKGROUND INFORMATION:

Because of low completion rates and a lack of workforce needs, an admissions stop-out of these certificates was approved April 6, 2016 (initiated in a memo from Charles Sasaki dated February 16, 2016). The last certificate completer graduated in 2015, and there have been no new program admissions since.

In September 2018, a request was submitted to de-activate AG classes specific to these programs. These de-activations have been approved (effective for Fall 2019).

Consequently, I am requesting terminations of the following three programs of study:

- Certificate of Competence in Agricultural Technology
- Certificate of Competence in Plant Landscaping
- Certificate of Competence in Subtropical Urban Tree Care

Per Regents Policy RP 5.201, "Provisional and established programs deemed out-of-date or nonproductive based on a program review or other internal assessments may be terminated by the president" and "Commitments to students already officially enrolled in such programs shall be met and limited for up to two years for associate degrees at community college programs and four years for baccalaureate degrees. No new program admissions shall take place." These criteria have been fulfilled.


ACTION RECOMMENDED:

Proposal: Termination of Certificates of Competence for Agriculture Programs






