Reclassification of General Arts & Sciences (GEAS) Category

Thank you for your assistance in enabling us to clarify the General Arts & Sciences category. After consultation with all parties involved and movement of various pre-major populations, the Mānoa Advising Center is requesting a reclassification of the following Banner codes, based on these changes:

- Pre-PSY moved under Arts & Sciences as of Summer 2011.
- As of Fall 2012, Education allowed Pre-ED, Pre-KRS students direct admission into their programs.
- Pre-NURS moved under School of Nursing and Dental Hygiene as of September 2012.
- Pre-ENGR moved under Engineering as of January 2013.

Students currently classified as General Arts & Sciences (GEAS) will now be simply reclassified as Exploratory. The name "Exploratory" classification was selected over "Undecided" or "Undecided" or "Undeclared" made it sound as though students were not degree-seeking and could be mistaken with "unclassified" students. In addition, this is the preferred term utilized by NACADA.

The following categories will remain: Exploratory (Pre-Business), Exploratory (Pre-Medical), Exploratory (Pre Medical Technology), Exploratory (Pre-Pharmacy), Exploratory (Pre-Dental Hygiene), Exploratory (Pre-Law) and Exploratory (Pre-Social Work.)

The categories Pre-Education and Pre-KRS will cease to exist since Education now allows direct admission into their college. As a result, remaining students classified as Pre-ED and Pre-KRS will be changed to Exploratory. Similarly the Pre-MATH and Pre-Speech Pathology and Audiology categories no longer exist and remaining students will be classified as Exploratory.

In order to reflect the correct classification of students, all exploratory majors will have their Banner college / school changed from Arts & Sciences to Office of Undergraduate Education.

Please review the attached chart with all changes and inform us whether our request has been granted. If and when approval is granted, Registrar Stuart Lau has graciously agreed to implement the changes to the students' records.

With the inter-related projects to collect both educational objectives and to move the "undeclared" students from Arts and Sciences to the Manoa Advising Center, it was discovered that the two projects were somewhat divergent. After a number of conversations with various parties involved, would the following coding structure be workable for both MAC and STAR:

- Change the description of the major GEAS to exploratory
- Create a new Banner program code to for the move from the "undeclared" students to OUE (MAC)
- Rather than create additional major codes for the "pre-majors", code the "pre-majors" as concentrations (student will still appear as "exploratory" with the "pre-major" being available on Banner as a concentration rather than a major)

This would allow for the current design of the ed goals (which has already been rolled out) to not change.

Question for Ryan: Am I correct in understanding that a student should not be able to select a "pre-major" during the application process but, rather would be assigned to the "pre-major" if not admissible to the intended program.

Please let me know if this would work for all parties involved. If yes, may I request an addendum to the current memo requesting the changes to the program codes to accommodate the move from A&S to OUE. Note: The changes affecting Pre-Engineering, Pre-Nursing, and Pre-Psychology are not impacted by this issue.
